Release and Waiver of Liability Form

1. This Release and Waiver of Liability (the "Release") is executed on _____ on behalf of _____ the "Participant."

2. Participant releases the Newcomers Club of Chico (the "Nonprofit") a Nonprofit Community Service Club organized and existing under the laws of the United States, as Section, 501(c) (7) tax exemption, each of its directors, officers, employees, volunteers and agents as follows:

3. Participant desires to engage in activities related to serving or participating in the Nonprofit's activities as a player, participant or volunteer. Participant is responsible for the Participant's own insurance coverage in the event of personal injury or illness as a result of participation in activities of the Nonprofit. Participant is aware of the risks associated with participation in Nonprofit activities, including traveling to/from any activities and assumes all risks, both known and unknown to me.

4. Waiver and Release: Participant releases and forever discharges and holds harmless Nonprofit and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the activities as a Participant with the Nonprofit, including claims arising out of negligence. Participant understands and acknowledges that the Release discharges Nonprofit from any liability or claim that Participant may have against Nonprofit with respect to bodily injury, personal injury, illness, death, property damage that may result from the Participant's involvement in the Nonprofit's activities.

5. Assumption of Risk: Participant understands that the activities provided by Nonprofit and which the Participant engages in may include activities that are inherently dangerous to Participant. Participant expressly assumes the risk of injury or harm from these activities and Release Nonprofit from any liability for injury, illness, death, or property damage resulting from these activities.

6. Voluntary Agreement and Negotiation: Participant acknowledges that she is over the age of eighteen. Participant understands and acknowledges that she is agreeing to the terms of this Waiver in exchange for being allowed to participate in the activities of the Nonprofit. Participant acknowledges and represents that she has read this Waiver, and she understands this Waiver. By signing below Participant is giving up important legal rights that Participant may otherwise have; and Participant is entering into this Waiver and choosing to participate in the activities of the Nonprofit of her own free will.
